# INFORMATION

10th Annual  
Memorial Day  
Tournament

**RULES:** This is a recreational angling tournament. No green sticks, no rod limit, spreader bars allowed, no harpoons. Accepted methods of recreational angling are allowed. Any questions regarding technique or equipment should be directed to the tournament chair at the Captain's meeting. A representative of each entry must be present at the Captain's meeting. No chunking in any OCMC Tournaments. Bailing dolphin is not allowed in OCMC tournaments.

**LAY DAY:** Must be declared by 10:00 a.m. NO EXCEPTIONS. Leave message at the Club: 410.213.1613. If no call is received by 10:00 a.m., boat or shore based angler is automatically considered as fishing. You may also declare a lay day at registration.

## FISHING GROUNDS

**OFFSHORE & INSHORE:** Boundary is 100 miles from Sea Buoy. You may depart from either Indian River Inlet or Ocean City Inlet and all fish must be weighed at Sunset Marina.

**SCORING:** Heaviest Fish Top Three Places - 1st, 2nd, 3rd State and Federal Minimum sizes apply.

The Marlin Club retains 10% of all Calcutta monies & a portion of the Entry Fee will go to the Catherine and Charles Kratz Memorial Foundation and Scholarship Fund. In the event no fish is caught in a particular Calcutta the money will be returned; less the 10% Marlin Club retention. All protests must be made to the Marlin Club President by 7:30 p.m. on Sunday, May 26 2019. The tournament will become official at 7:30 p.m. on Monday, May 27, 2019. Winner payment - All winners must complete a W-9 form. All checks will be mailed by 12:00 p.m. on Wednesday, May 29, 2019. In the event of a tie, the money will be split equally.
